**FEE ELIGIBILITY** – in the case of a dog aged 6 months or older at 1 July 2018, all fees must be paid in full by 31 July 2018. In the case of a dog passing the age of 6 months after 30 June, fees must be paid by the 30th day of the month in which the dog passes that age.

**NEW DOGS** – fees must be paid within 14 days after you acquire the dog.

**CONCESSION/HEALTH CARE CARD HOLDERS** – you must produce a Commonwealth Pensioner Concession Card, Repatriation Health Card or Health Care Card.

**DESEXED DOGS** – you must produce a veterinarian's certificate of desexing at the time of initial registration to qualify for the discount.

**SPECIAL ASSISTANCE DOG** – you must produce evidence that the dog is a guide dog, as defined by the *Guide Dogs and Hearing Dogs Act 1967*, or is training to be a guide dog.
