Council's Standard Waste Service is 1x 140L refuse bin and 1x 240L recycle bin for ALL residential properties.

This service is for domestic waste types only and the provision of this service to Commercial properties is entirely at the discretion of Council.

Applications for a New Service or an Upgrade of Refuse bin require the approval of the owner of the property.

All application forms must be received by 2pm on Thursdays. Deliveries and repairs are made on Fridays each week following approval of the application.

For all bin services please ensure that bins are empty and placed on the kerbside before 7am.
