**PLEASE NOTE:**

Wheelie bins are the property of Glenorchy City Council and must remain at the premises to which they are allocated.

Council's Fortnightly Standard Kerbside Waste Service is 1x 140L waste bin, 1x 240L recycle bin and 1 x 240L FOGO (Food Organics Garden Organics) bin for ALL residential properties. Where residents in a unit complex have Shared bins, the standard service is 240L for Waste, Recycling and FOGO bins.

This service is for domestic waste types only and the provision of this service to Commercial properties is entirely at the discretion of Council.

Applications for a New Service must have an Occupancy or Final Certificate and approval of the property owner.

Upgrade of Waste bin or Downgrade of bins must have the approval of the property owner.

Please note: Criteria for Upgrade of waste bins is on front of the form. Note: not available for residents where there are Shared Bins.

In some circumstances a Non-standard Waste Service charges may apply for a fortnightly collection at the discretion of Council.

All application forms must be received by 2pm on Thursdays, may change at the discretion of Council. Deliveries and repairs are made on Fridays each week following approval of the application.

For all bin maintenance services please ensure that bins are empty and placed on the kerbside before 6am.
