For quarter one (Q1) of 2021/22 Council received **202** planning applications comprising of:

While there was a slight increase in the number of discretionary, permitted and S56 amendment applications, there was a clear spike in the number of NPR applications received, seeing an increase of 11 applications for this application type. This may be attributed to the current housing demand and market trends.

It is noted that the NPR certification does not result in a planning permit being issued. However, this is a service offered by Council and the time spent by planning staff to assess this application type is equivalent to that of a permitted planning application, where Council must grant a permit. The NPR applications contribute to, and are reflective of, the level of development activity in the municipality and should be represented in the over planning statistics.




Fig 1: Planning Applications Received Per Quarter

There is an upward trend observed for the number of applications received for the first quarter of 2021/2022 performing well above the four-year rolling average of **133**(Fig. 1).

Application Processing Times

Discretionary Applications





Fig 2: Processing Times for Discretionary Applications

The average processing time for discretionary applications decreased from 41 days in Q4 to 38 days in this first quarter of 2021/22 (Fig. 2).

Permitted Applications


For permitted applications, the average processing time went down marginally from 27 days 25.5 days in this quarter (Fig. 3).





Section 56 Amendment Applications

The average processing time for S56 minor amendment applications increased from 11 days in the previous quarter to 20 days (Fig. 4). The Planning Authority has 28 days to determine a S56 minor amendment application.



Quarter/Year

The processing times for Q1 remain within the 28-day and 42-day statutory time limits that apply to S56 minor amendment applications, permitted and discretionary applications respectively.

No Permit Required (NPR) Applications


Thirty NPR applications were decided this quarter (Fig. 5).

Planning Appeals

There were no appeals lodged in the first quarter of 2021/22 (Fig. 6).



The emphasis continues to be placed on negotiation with the applicant (and occasionally, the representor) of any issues raised in the assessment of planning applications. This approach has contributed to fewer appeals to the Tasmanian Civil and Administrative Tribunal (TASCAT). It has also resulted in most appeals being mediated and settled without the need for a full hearing.
